International Registry Update for POAs

Pursuant to a mandate issued by the International Registry effective December 1, 2006, the requirements have changed for appointment of Insured Aircraft Title Service, Inc. as Administrator for entities.

In order to process your application with the International Registry, the following documentation will need to be provided to IATS:

- 1.) "Confirmation of Entitlement to Act" on company letterhead in the format set out on page two herein
- 2.) Web address (if any)
- 3.) One of the following:
 - Certification of Incorporation
 - EIN Form
 - Articles of formation/organization
 - LLC Statement in Support of Registration (A sample form attached hereto)
- 4.) Credit Card Authorization (Form attached hereto)

Compliance with the above is the minimum essential requirement for the processing of your application. In certain cases the registry may request additional information at which time we will contact you for additional information.

In the case of an individual, items 1 and 4 should be sufficient.
